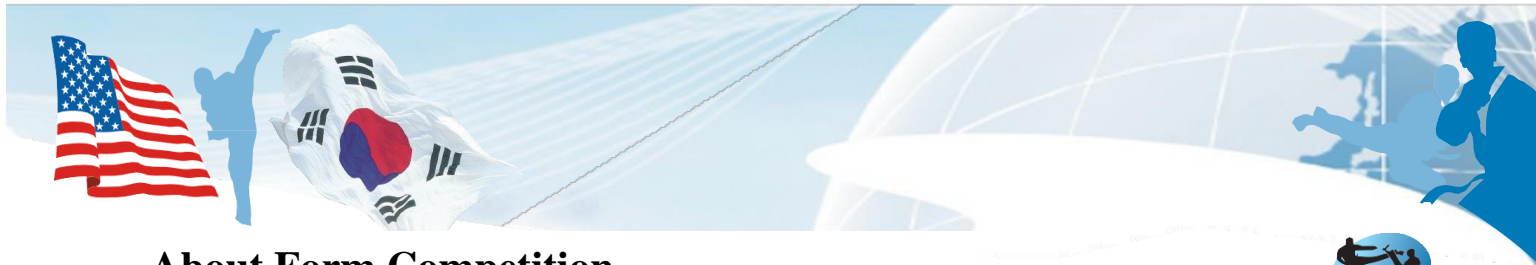

## About Board Breaking Competition

- Color belts follow official's direction. Black belts do their own routine.
  - White to Green belts need 3 board and Blue to Deputy belts need 4 boards and 4 techniques, Black Belts need 4 boards and 4 free style techniques.
  - Board set up time is up to 30 seconds with judges.
  - Never use a chair, person, or any other equipment to set up
  - There are three chances for each breaking.
  - 3~7yrs old use Pee Wee Board 8~11yrs old use Child Board, 12~17yrs Teen Board and 18 & Up use Adult Board.
  - **Board Breaking : GUARANTEED RESULT**
- 1<sup>st</sup> Place – No or 1 mistake on breaking the board**  
**2<sup>nd</sup> Place – 2 or 3 mistakes on breaking the board**  
**3<sup>rd</sup> place – 4 & more**

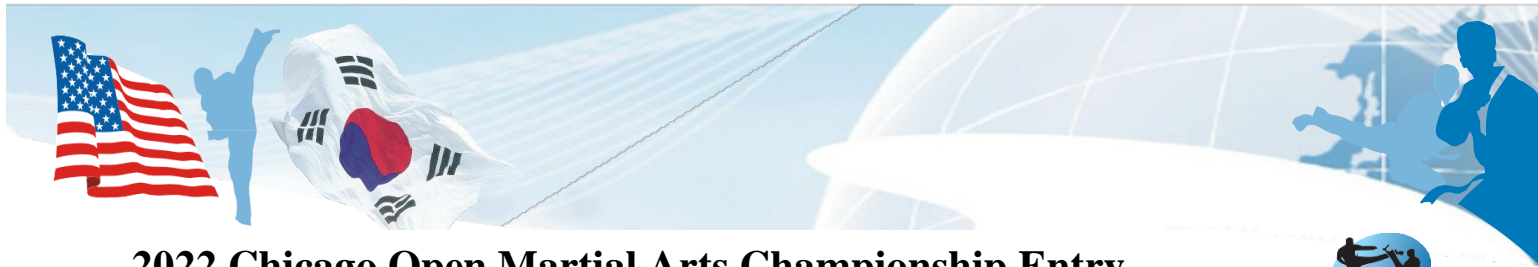
## About Sparring Competition

### OFFICIAL SPARRING RULES

- Modified USAT/CMA Sparring rules will apply
- Mandatory Equipment is required for this event
- Sparring has two Divisions  
(A group: Competitors have a high level of experience in tournaments)  
(B group: Competitors have a low level of experience in tournaments)
- **Round Time(A/B group)**
  - 1Min x 2 rounds (30sec Rest time)– All Color Belt
  - 1Min30sec x 2 round(30sec Rest Time) – All Black Belt
- **Point(A group)**
  - 1point – Valid punch or kick on chest protector
  - 2point – Valid turning kick on chest protector
  - 3point – Valid kick to the head, Black Belts only
  - 4point – Valid turning kick to the head, Black Belt only
- **Point(B group)**
  - 1point – Valid punch or kick on chest protector
  - 2point – Valid turning kick on chest protector
- **Application of head contact safety rules(A group)**
  - No head contact: all color belts and black belts ages 13 and under
  - Head contact: Black belt ages 14 and up
- **Application of head contact safety rules(B group)**
  - No head contact: all color belts and black belts
  - When the match is tied, a single sudden death round will apply
